

First Supplement dated 24 November 2014 to the Base Prospectus dated 26 June 2014

of

BINCKBANK N.V.

(a public limited liability company incorporated in the Netherlands
with its statutory seat in Amsterdam, the Netherlands)



BinckBank N.V. ("**BinckBank**" or the "**Issuer**") may from time to time, issue Turbo's and Turbo's XL (the "**Securities**", and each a "**Security**") under a base prospectus dated 26 June 2014 ("**Base Prospectus**"). This first supplemental prospectus ("**First Supplemental Prospectus**") is based on Article 5:23 of the Dutch Financial Supervision Act (*Wet op het financieel toezicht*) ("**DFSA**") and has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*) ("**AFM**"). The purpose of this First Supplemental Prospectus is to incorporate by reference a press release published by BinckBank on 29 October 2014 with respect to the stepping down of the BinckBank CEO on 1 January 2015. Mr Beentjes will hand over his duties to the two other executive directors, Messrs Germyns and Kooistra. Mr Germyns will take on the role of chairman on an interim basis. Terms used but not described in this First Supplement have the meanings ascribed to them in the Base Prospectus.

This First Supplemental Prospectus is supplemental to, forms part of and should be read in conjunction and construed together with the Base Prospectus including any documents incorporated by reference therein and, in relation to any Series, the Base Prospectus and this First Supplemental Prospectus should be read and construed together with the relevant Final Terms. Bestuursvoorzitter BinckBank treedt per 1 januari 2015 terug

De bestuursvoorzitter van BinckBank, de heer K.N. Beentjes (53) treedt per 1 januari 2015 terug. De heer Beentjes is op de algemene vergadering van 2009 benoemd. Onder zijn leiding heeft BinckBank recentelijk focus aangebracht op haar Retailactiviteiten. BinckBank maakt zich in dat verband op voor een nieuwe fase waaraan een nieuwe voorzitter leiding zal gaan geven. Partijen hebben daartoe in goed onderling overleg besloten.

De raad van commissarissen beraadt zich de komende periode over de definitieve invulling van het bestuur. De heer Beentjes zal zijn taken overdragen aan de twee andere bestuurders, de heren Germyns en Kooistra, waarbij de heer Germyns tijdelijk de voorzittersrol op zich zal nemen. Voorts zal commissaris de heer Deuzeman worden aangewezen als gedelegeerd commissaris. Commissaris mevrouw Van der Weerd-Norder zal zijn rol als voorzitter van de Auditcommissie waarnemen. De beoogde invulling van de voorzittersrol door de heer Germyns is formeel onderworpen aan het oordeel van De Nederlandsche Bank.

De raad van commissarissen dankt de heer Beentjes voor zijn inzet en betrokkenheid bij BinckBank in de afgelopen jaren en wenst hem succes in het vervolg van zijn carrière.
